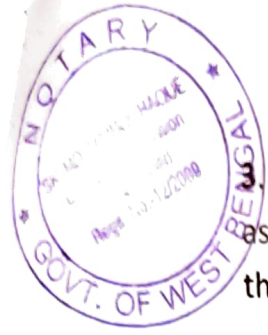
AFFIDAVIT

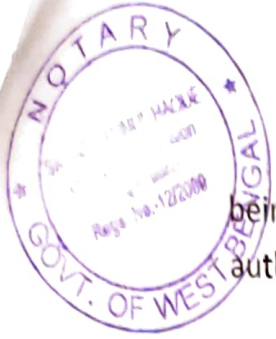
5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body .
