THIS DEED OF TRUST is made on this 07<sup>th</sup> day of February 2017, BEWEEN Smt. Rupalisha Ghosh (Sarkar), D/o- Ajit Kr. Ghosh, residing at Sahanagar, P.O. & P.S. – Murshidabad, Dist.- Murshidabad, PAN-AKAPG8604Q, hereinafter called the SETTLER (which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include her heirs successors, executors, administrators, legal representatives and assigns) of the ONE PARTY.

(3) **Smt. Monalisha Nayek**, W/O – **Susanta Nayek** , PAN-AELPN8688N, residing at Bakari Gali, Murshidabad jointly hereinafter called the Trustees (Which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and included its heirs , successors executors , administrators , legal representatives and assigns) **OF THE OTHER PART.**

WHEREAS for good reasons and consideration and in order to perpetrate the memory of the Settler's father in law and mother the Settler is desirous of establishing school and Educational Institution to be named as "**Surya Memorial Academy**" for the purpose as hereinafter maintained to the Trust named as "**Shri Shri Manjushri Welfare Trust.**"

NAME OF THE TRUST:

"**Shri Shri Manjushri Welfare Trust.**"

**NOW THIS INDENTURE WITNESSES:**

1. In pursuance of the said wish and desire of the Settler the Settler do hereby grant convey, transfer assign and assure to the Trustees ALL THAT trust property TO HAVE AND TO HOLD the same upon Trust for the object and with intent in subject to the powers, provision and agreement hereunder detailed and expressed concerning the same.
2. The Trustees shall erect, build, construct a building suitable for a school and any other Educational Institution at their own cost as the Trustees may think proper.
3. The Trustees shall manage and develop the school and Educational Institution after its construction according to the plan sanctioned by Appropriate Authority and to pay Govt. Revenue and tax to Appropriate Authority and other



impositions out of the income from collection of tuition fees, Admission Fee, Development Fee, and Donation to be collected from the Students.

4. The office of the trust shall be situated at Koiripara, Kapasdanga, Ransagar, Murshidabad, West Bengal and/or at such other place or places as the trustees may from time to time decide.

5. The number of the trustees shall be not more than 14(fourteen) and not less than 2(two).

6. The object of the said Trust shall be:

(i) To establish, Promote, set up, run, maintain the said school and other institution like P.T.T.I. Institution, B.ED Training Institution, Engineering College, Medical College other technological institution and social development institute, vocational institution in the said complex upon the land described in schedule below or other places as to be acquired either by gift or purchase in the name of self-same Trust.

(ii) To open found establish , promote , run , maintained school , college for advancement of education and knowledge in Arts, Science , Literature Humanities , commerce , Information Technology and College of Management Education .

(iii) To open, found, promote higher education including fine arts, craft etc.

(iv) To construct building of hostel for boarding the students, play ground for the students to be used for sports and games.

(v) To get educational institution registered with the Registering Authorities throughout the Indian territory in compliance of law and rules of the Govt. and semi-Govt. and Educational authorities.

(vi) To appoint teachers, professors, technicians and all other required personnels for running the educational institutions.

(vii) To cause the sanctions of various funds from various financial aids.

(viii) To receive money and may accept donation and contribution in cash or in any form from any citizen of India and non-citizen from abroad and from various commercial authorities from India or abroad, corporation company association or from any trust.

(ix) To obtain affiliation of the course and degree of the said educational institutions from foreign universities, Board or any name they are called.

(x) To eradicate various diseases of human body by providing medical facilities of any nature to citizen at large and to form Medical Institution Nursing Home , Hospital as well as Medical College and Hospital for providing Medical Education.

(xi) To materialize the environmental problems through the Indian Territory and to so all acts fort such process and to form institutes etc. for such purposes.

(xii) Generally to do all acts and things as may appear to the Trustees in their directions concerning to any other purposes as may be found proper by the Trustees.

Thereby to say that the trustees will be at liberty to all acts as owner and possessor of the Trust Estate for the protection, Preservation, investigation, verification, transaction, conveyance or each and every proprietary acts and to do all ministerial job and acts whatsoever may be necessary in all time to come.

(xiii) To grant, donate, aid to contribute or subscribe to other Trusts or Institutions or work with other trusts or institutions having similar objects and also grant charity to the poor.

(xiv) That any member of the trust body may be removed by the president.

(xv) That the following persons hereby appointed as Trustees of the said Trust Board.

1. Rupalisha Ghosh      D/O    Ajit Kumar Ghosh      : President

2. Manjushri Ghosh      W/O    Ajit Kumar Ghosh      : Vice-President

3. MonalishaNayek      D/O    Ajit Kumar Ghosh      : Secretary

(xvi) That all meetings of the members of the Boards of Trustees will be presided over by the President and in his absence by the Vice-President.

(xvii) That the members of the Trustees or the Trustees or the President of the Trust while holding meeting and taking decision and doing any act jointly will be taking as the act of Trust.



(xviii) That all the Trustees will constitute Board of Trustee consisting themselves and they can appoint, nominate any other persons interested in the education as Trustees, subject to the approval of the President. If the President does not accord approval in such appointment or nomination and introduction any person as Trustees the same shall not be effected.

(xix) That in case of death of any member of the Trust, the Board of Trustees will adopt and admit a new member by unanimous decision .however if the Board fails to take unanimous decision , the President will have the right to appoint the members without assigning any reason whatsoever.

(xx) That all the members of the Board of Trustee will be treated as the first member of the Trust and the office of the Trustees shall if so fact to become vacant on the happening of the following:

- a)Death
- b)Insolvency
- c)Resignation subject to acceptance by the Board of trustees .
- d)On being rendered incapable to perform the duties due to old age or continuous illness.
- e)On being convicted of any offence for more that 3 months involving moral turpitude.
- f)On failure to attend four consecutive meeting of the Board of Trustee without sufficient cause or without previous intimation.
- g) On being adjudicated as an insolvent by the Competent Court .
- h) On being removed of impeached by the majority members of Board of Trustee or by President at his discretion.

That the President of the Board of Trustee shall all along become from the members of the family of Settler In is also made clear that the President shall nominate any member of Board of families who must be his family member as next president after his death in his place. The vacancy of any trustee Member will be filled in by nomination

the President. During the vacancy in the said way the President will have the power to take decision in case of the meeting of the Board of Trustee. However no posts of any member will remain vacant for more that 3 months.

That notwithstanding anything stated herein before of hereinafter the President shall in case of any emergency be authorized to take any decision for emergency affairs ad all fulfilling emergency needs. The said decision will however be placed for approval before the Board for Trustee in its next meeting.

That the board of Trustee shall meet at least twice a year at an interval of six months in ordinary course. In any occasion emergency Board of trustee may be called for by the President or the Vice-President or the Secretary at any time subject to three days notice in writing or over telephone to inform to each member indicating the business to be transaction or discussed.

That the President can nominate any member of the Trust Body for the post of President at his discretion. However , in the absence of such nomination and if the post so falls vacant due to any reason whatsoever , any other members of the Trust Body can be nominated to the post of President with majority.

That the President will be Chairman of any such Institution or organization run, managed .operated and controlled by the trust . That all the proceeding of the Board of Trustee meeting is to be recorded in writing either by the Secretary or by the Vice President in a Resolution Book which is to be kept in the custody of President and the same will be signed by the members present in such meeting.

That the trustee shall have the following powers.

1. To possess and manage the Trust estate, Trust properties and Trust fund .The investment for the time being representing the Trust fund and to do all acts required for the maintenance and preservation thereof.
2. To pay all expenses relating to the affairs administration and management of the Trust.
3. To keep and maintain accurate accounts of the Income and Expenditure of the Trust.
4. To conduct correspondence on behalf of the trust.



5. The Trustees shall keep or cause to be kept proper books of account wherein shall be kept an account of the Trust Fund receipts and disbursement and shall appoint a Chartered Accountant to be the Auditor of the Trust Fund and shall have the accounts audited by the said Auditor once at least every year.
6. To demand realize and receive all interest , dividends , rent and other income and money of the Trust or its property and Investment from person , firms or companies and public debt offices liable to pay the same .
7. To deposit the income of the Trust fund with any national or scheduled Bank and the same shall be operated by President or by others.
8. To invest moneys of the Trust not immediately required for the purpose in such manner and upon such terms as the trustees may think fit and proper subject however to the provisions of the Income Tax Act, 1961 or any statutory modifications thereof.
9. To amalgamate this Trust with any other Trust having similar objects or to get other Trust having similar objects amalgamated with this Trust with prior sanction of all the Trustees in the meeting and subject to approval of appropriate Authority under the Income Tax, if required.
10. The Trustees may from time to time open and maintain in their own names or in the name of the Trust a Banking Account or accounts and may operate the same or authorize any one or more of them from time to time operate the same.
11. The Trustees shall be at liberty to sell, call in or convert into money the properties of the trust or the investment and to vary the investments from time to time and reinvest the same their discretion for the benefit of the trust and the compliance of objective of the Trust.
12. No Portion of the Trust fund shall be lent to any of the Trustees nor shall be Trustee apply the Trust fund or any portion thereof for their own use directly or indirectly.
13. To appoint all types of employees for managing and carrying out the affairs of the Trust or for collection of income thereof pay and fix such salaries or remuneration as the Trustees may deem fit.



14. To nominate, constitute and appoint attorney or agent and delegate to such attorney or agent all or any of the powers vested in them under their presents.

15. To accept donations contribution, either in cash or in kind for the object and purpose of trust from any person or persons if the Trustees so approve and on such terms and subject to such conditions as may be agreed to.

16. The Board of Trustees will have the power to amend / incorporate any additional provision in future with the consent of 2/3 majority in meeting of the Board of Trustees with the approval of the President.

17. To frame and with a notice of once month vary, amend or alter schemes, Rules Regulations and bye -laws for the management and administration of the Trust, its properties and the institutions run by the Trust.

18. The Trustees may at any time wind up the Trust provided all the Trustees agree to such winding up and in such a case the Trustees shall realize all securities and prepare and/or complete the accounts of the Fund and after payment of all costs and expenses of winding up of the Fund, they shall distribute and/or donate funds and/or assets remaining in their hand among charitable Institution or Institutions and in such proportion as they may think fit and proper .

19. The Settlor hereby reserves the power and may confer such or any of such powers upon the Trustees to alter any of the above clauses only subject of the approval of the tax authorities (including Income Tax authorities) so that the exemptions granted by the Tax Authorities to this Trust and in order that the donations/contributions to the Trust Fund could qualify and continue to qualify for deductions under applicable provisions of the Income Tax Act, 1961 and /or other relevant provisions thereof .

That the Board of Trusts will have the right to float or incorporate any association or society for particular and respective purposes for controlling managing any Educational Institutions or Development Institutions . However the Committee or Board of such Association or Society shall be responsible to the Board of Trust of this Trust.

That the income of Board of Trustees will be from the investment that may be made by the members of Trustees or from any financial resources for complying with the objective of the Trust.
